


Printing Copies of IRS Form 1099-R from *My Account*

If you receive a pension benefit and a beneficiary benefit **OR** if you receive multiple pension benefits, you will need to print multiple 1099-Rs from *My Account* to obtain all of your required tax information. If you...



You will need to choose which account you would like to view or print. If you click on “Other Accounts” you will see a list of available accounts. Choose either member information or beneficiary.

Receive Multiple Pension or Beneficiary Benefits

Once you choose the account you would like to view/print the Form 1099-R for, select “IRS Tax Form” from the menu on the left of the page and choose the “Tax Year” you would like to print the 1099-R for on the top right of the page. If you receive multiple pension benefits or multiple beneficiary benefits you will need to choose the appropriate benefit from the drop down menu next to “Benefit Type” and print an individual 1099-R for each benefit you receive.
